



Referee Declaration Form Guidance

Use this form to verify the identity of an individual applying for the Cayman Islands Identification Card. This form must be completed by a referee who meets the below criteria and can attest to the identity of the individual for who they are being a reference.

Before proceeding, please note referees must:

- be a person of good standing in the Cayman Islands who holds a recognised professional role (see list in Section 2)
- have known the applicant for at least 3 years
- not share the same address as the applicant
- not be related to applicant (by birth or marriage)
- be a resident of the Cayman Islands
- be over the age of 25
- not work the Department of eGovernment or any other Cayman Islands Government entity involved in the processing or issuance of Cayman Islands Identification Cards or enrollment in the Identification Register
- not have been convicted of an imprisonable offence during the last 10 years
