



# Application For The Cayman Islands Identification Card

## Application Guidance

This application is for the enrolment of the applicant in the Identification Register in accordance with the Identification Register Act, 2022 and Regulations, 2025, and the issuance of a Cayman Islands Identification Card in accordance with the Cayman Islands Identification Card Act, 2022 and Regulations, 2025.

In compliance with these Acts and Regulations, the information and supporting documents specified in this application form are required to process the application. This information is collected to verify the identity of the applicant and other involved parties, to ensure their authority to apply, eligibility, accuracy and that the Cayman Islands Identification Card is delivered to the right person.

Additionally, you will be asked to provide valid proof of identity (preferably a passport) for all persons involved in this application to support the information provided on this form.

Please ensure that all information submitted is accurate and up to date in accordance with your obligations under section 24 of the Identification Register Act, 2022.

Particularly relevant sections of the legislation include but is not limited to:

- Section 5 of the Cayman Islands Identification Card Act, 2022, and Section 2 of the Cayman Islands Identification Card Regulations, 2025, titled "Application for the issuance, renewal or replacement of Cayman Islands Identification Card" and;
- Section 5 of the Identification Register Act, 2022 and Section 3 of the Identification Register Regulations, 2025, titled "Entry of a person in the register" and;
- Section 11 of the Identification Register Act, 2022 and Section 8 of the Identification Register Regulations, 2025, titled "Delegated authority" and;
- Section 24 of the Identification Register Act, 2022, titled "Obligations of persons submitting data"

To process an application for a minor, by a parent, we require the identity information of the parent and proof of their relationship to the minor e.g. birth certificate; for an application by a legal guardian, we will require proof of the legal guardian's identity and confirming guardianship e.g. court document.

If the parent/s is enrolled in the Identification Register, their ID code/s will be added to the minor's record as Parent 1 and/or Parent 2.

The identification code assigned to the person shall not be assigned or re-assigned to, or re-used by, any other person during the lifetime, or after the death, of the registered person.\*
